- AP – Accounts Payable (Invoices and Receiving Tickets, etc.)

## **12 Noon Closing**

Tier TWO modules will be placed in **PRELIMINARY** close for the **June 2016 General Ledger**

- BE – Budget Execution (Resources, Apportionments, Allotments, BOPs)  
**NOTE:** Month end G/L closing process does NOT prohibit end users from entering BOPs.
- AR – Accounts Receivable
- ALLOC – Cost Accumulation/Allocation (Surcharges, etc.)  
The Cost Accumulation Over/Under (CA O/U) process: 7:00 AM ET on Thursday June 30, 2016.
- GJ – General Journal (GJs may be entered until 12 noon)
- GL – General Ledger
